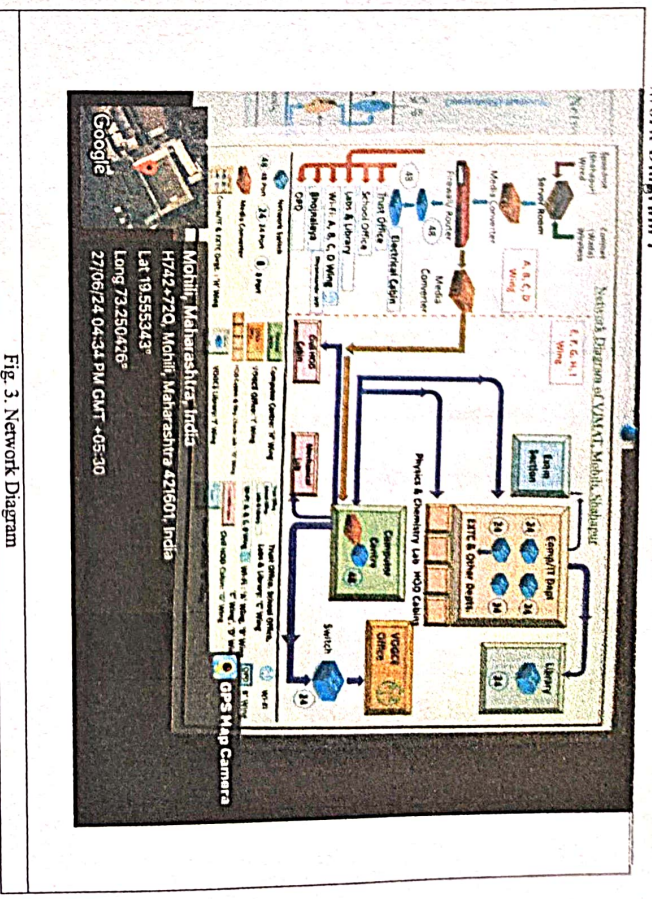


Fig. 3. Network Diagram

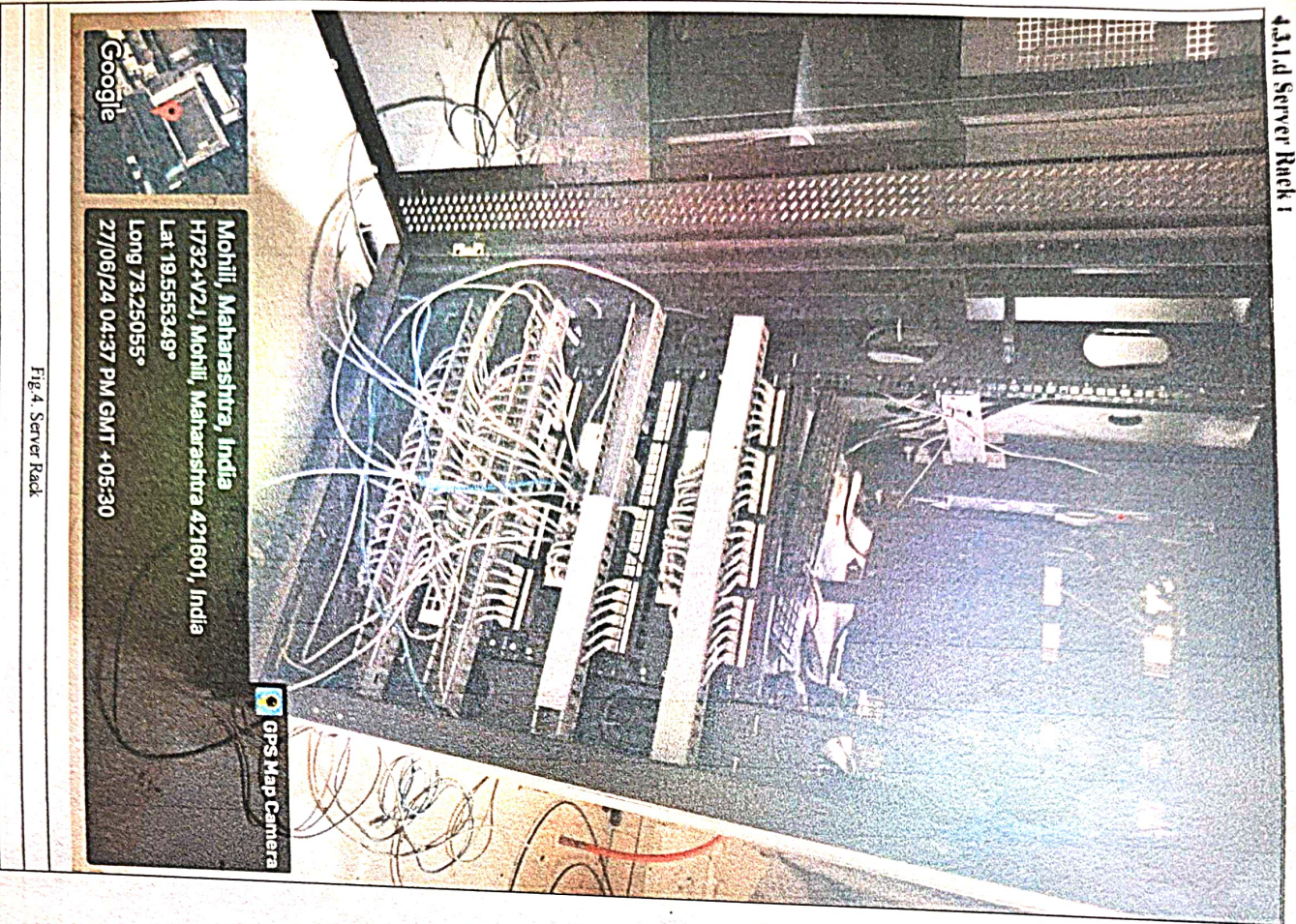


Fig. 4. Server Rack

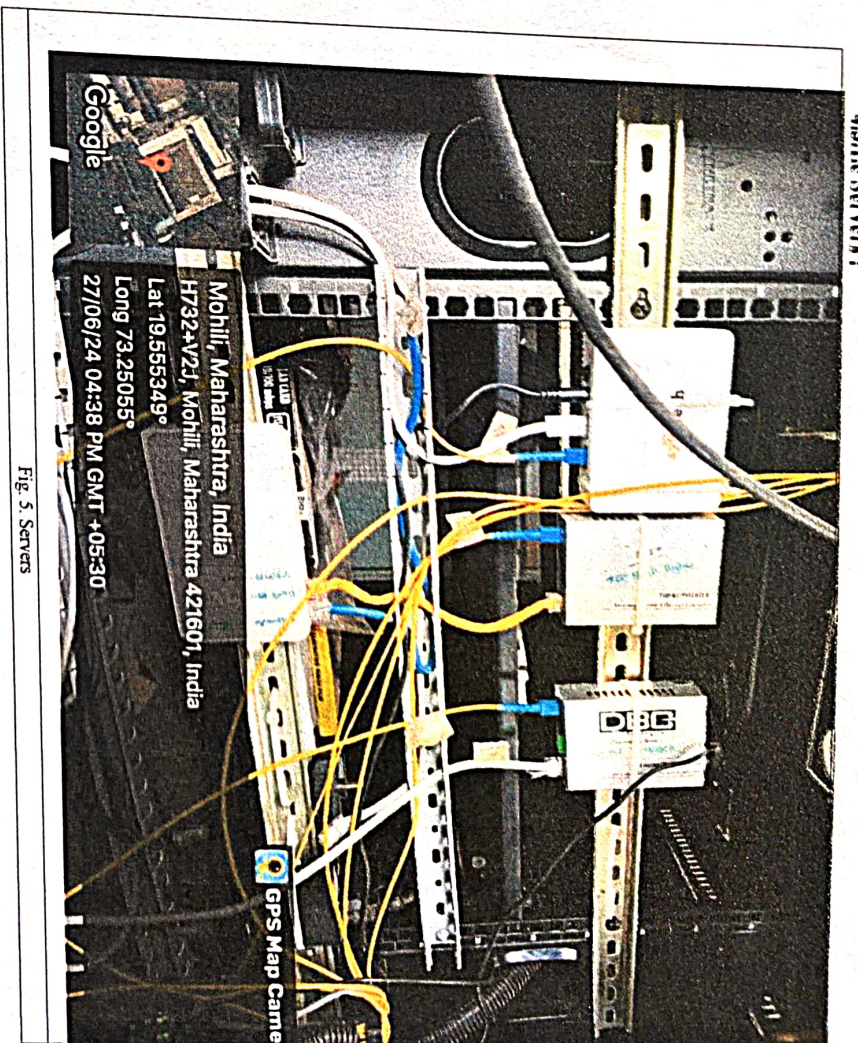


Fig. 5. Servers

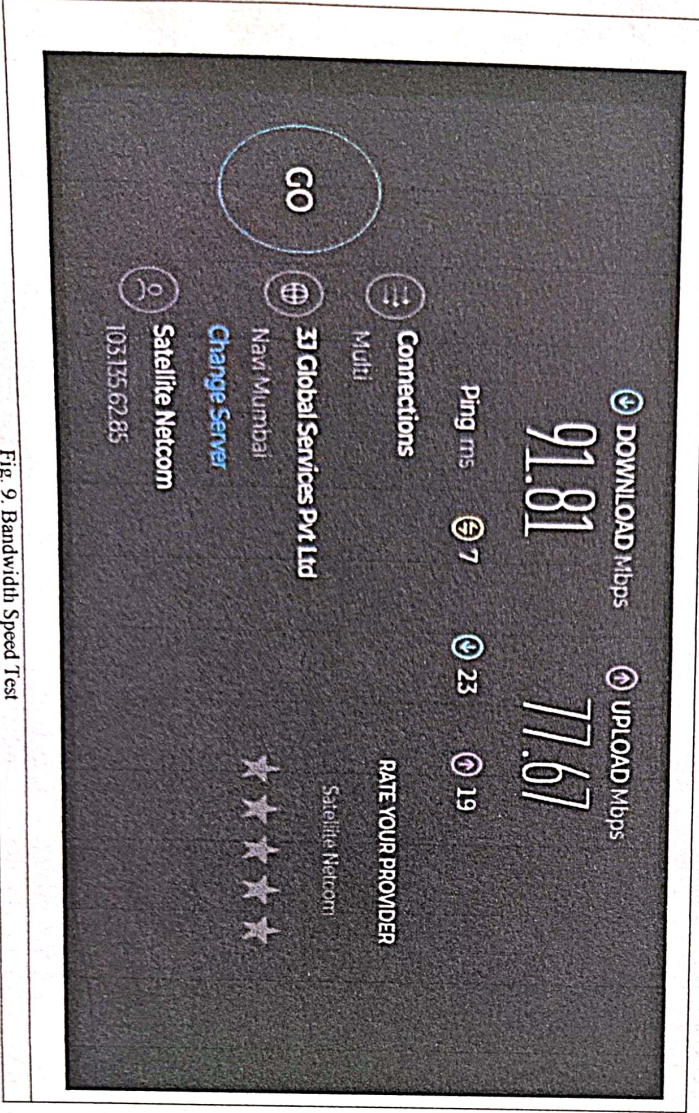


Fig. 9. Bandwidth Speed Test
