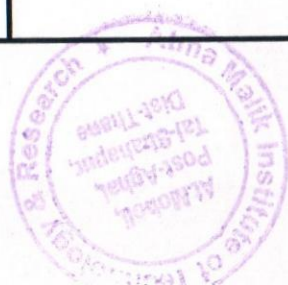

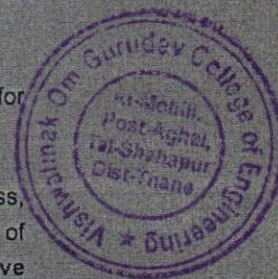
### **WHEREAS:**

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTHIN  
THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:

**CLAUSE 1**  
**CO-OPERATION**

- 1.1 Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the **Institution** and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.
- 1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of First Party providing significant inputs to them in developing suitable teaching / training systems, keeping in mind the needsof the industry, the Second Party.
- 1.3 The general terms of co-operation shall be governed by this MOU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MOU. The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

**CLAUSE 2**  
**SCOPE OF THE MOU**

- 2.1 The budding graduates from the institutions could play a key role in technological up-gradation, innovation and competitiveness of an industry. Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.
- 2.2 **Curriculum Design:** Second Party will give valuable inputs to the First Party in teaching / training methodology and suitably customize the curriculum so that the students fit into the industrial scenario meaningfully.
- 2.3 **Industrial Training & Visits:** Industry and Institution interaction will give an insight in to the latest developments / requirements of the industries; the Second Party to permit the Faculty and Students of the First Party to visit its group companies and also involve in Industrial Training Programs for the First Party as per the terms of second party. The industrial training and exposure provided to students and faculty through this association willbuild confidence and prepare the students to have a smooth transition from academic to working career. The Second Party will provide its Labs / Workshops / Industrial Sites for the hands-on training of the learners enrolled with the First Party, if they adhere and agree to the terms of second party.
- 2.4 **Research and Development:** Both Parties have agreed to carry out the joint research activities.
- 2.5 **Skill Development Programs:** Second Party to train the students of First Party on

- 2.6 **Guest Lectures:** Second Party to extend the necessary support to deliver guest lectures to the students of the First Party on the technology trends and in house requirements.
- 2.7 **Faculty Development Programs:** Second Party to train the Faculties of First Party for imparting training as per the industrial requirement considering the National Occupational Standards in concerned sector, if available.
- 2.8 **Placement of Trained Students:** Second Party will support and assist to help the delivery of the training and placement of students of the First Party into internships/jobs depending on the caliber / understanding of the trained students and the adherence and acceptance of terms of second party..
- 2.9 Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required for offering the Programmes on the terms specified herein all the above points mentioned will be as per the applicable terms and adherences to second party compliances and agreements.
- 2.10 There is no financial commitment on the part of the **Vishwatmak Om Gurudev College of Engineering**, the First Party to take up any programme mentioned in the MoU. If there is any financial consideration, it will be dealt separately.

### CLAUSE 3 INTELLECTUAL PROPERTY

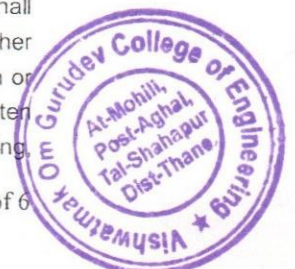

### CLAUSE 4 VALIDITY

- 4.1 This Agreement will be valid for 1 year or terminated by either Party on mutually agreed terms, during which period **Nashik Engineering Cluster**, the Second Party, as the case may be, will take effective steps for implementation of this MOU. Any act on the part of **NEC**, the Second Party after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MOU.
- 4.2 Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations.

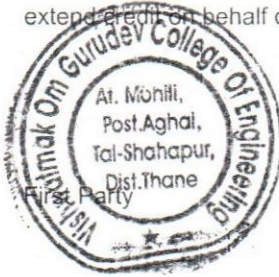
### CLAUSE 5 RELATIONSHIP BETWEEN THE PARTIES

This undertaking is to be construed in accordance with Indian Law with exclusive jurisdiction in the Courts of Thane.

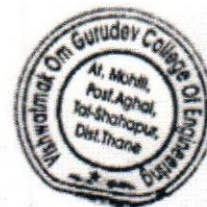
2. Coordination: Both organizations will designate one course co ordinator who will have responsibility for the coordination and implementation of this agreement.

**CLAUSE 1
